#### Renew Vehicle Stickers Online



Every vehicle registered to a Franklin Park resident needs a vehicle sticker including cars, trucks, motorcycles, etc. Stickers must be displayed on the lower right corner of your windshield by July 31. Passenger car stickers cost \$30. Seniors, who are 65 or older, receive one free vehicle sticker per household. Owners of electric vehicles receive a free vehicle sticker and hybrid vehicles pay a reduced rate of \$15.

Please renew your vehicle sticker online, by mail or by using the drop box in the parking lot to avoid long lines at Village Hall. The sticker will be mailed to you. If you are a resident and have purchased a new vehicle or recently moved to Franklin Park, you must provide a copy of your license plate registration showing your Franklin Park address in order to purchase a sticker. #### Have You Responded to the Census?

The census data will be used to determine the distribution of billions of dollars in federal funds that are used in education, local health care, housing and employment programs. If Franklin Park is under counted because not everyone responds, our schools and other programs may not get the funding they deserve.

The Census count should include everyone in your household, no matter their age, gender or ethnicity. People who may be living at your address temporarily should be counted too. The more people who are accurately counted in the Census, the more money Franklin Park will get from state and federal funds! This data is highly secure, and by law cannot be shared with immigration or law enforcement agencies or affect government benefits. It only takes a few minutes and is easy to respond. Officers who carry any special weapons or equipment must be retrained and requalified annually. Most importantly, we will abide by the principle that it should be the last resort to take a human life.

We are undertaking a review of departmental policies including our use of force procedures and we are committed to enacting reforms, as necessary. We are open to modernizing our policies and providing training to ensure the highest level of safety for the public and for our officers. We are currently seeking grants to obtain state-of-the-art equipment that will increase transparency and accountability. We are committed to maintaining and enhancing an environment where we work in partnership with the community to make certain that everyone's rights are preserved.

#### Watch for Lane Closures on Mannheim Road

Beginning the week of July 11, traffic on Mannheim Road will be reduced by a single lane (intermittently) in both directions under I-294 as needed between 9 AM and 3:30 PM. These closures are needed to provide a safe work zone for workers and accommodate drivers while substructure concrete repairs and electrical work take place on the I-294 bridge over the Bensenville Rail Yard. When there is no active work, all lanes on Mannheim Road will be reopened until work zones and closures are needed again. The work is anticipated to occur through July, weather permitting. #### Village Hall Offering Public Access - Special Senior Hours

Beginning on Monday, July 13, Village Hall will be open to the community with strict social distancing policies. To maintain the health and safety of our residents and employees, anyone entering Village Hall will be required to wear a face mask and to maintain a social distance of six feet or more while in the building. Please note that a limited number of visitors will be allowed in the building at one time and you may be required to wait outside until it is safe for you to enter.

Village Hall will be open to the public starting July 13 on Monday through Friday from 8 AM to 4:30 PM. Please visit our website at vofp.com before visiting Village Hall to access forms that can be filled out in advance to help speed processing. We anticipate long wait times at Village Hall during the next few weeks.

Residents 60 years or older and anyone with an underlining health condition or disability, are encouraged to visit Village Hall from 8 to 10 AM, Monday through Friday. The Village is asking the community to please refrain from visiting during this time that is being set aside for seniors and those with health issues so they can be accommodated quickly and efficiently.

The Building Department will be open for walk-ins and encourages homeowners and business owners seeking a permit to visit Village Hall between the hours of 10 AM and 4:30 PM. Special arrangements can be facilitated by calling (847) 671-8245. Permits can be obtained by using our online services. You can also fill out forms and put them in the parking lot drop box and someone will contact you to pick up the permit. For more information go to vofp.com.

The Clerk's Office will be open for walk-ins but is encouraging you to utilize online services if possible. For forms or questions, you can email at clerk@vofp.com or call (847) 671-8242. Garage sale registration, yard party and/or Freedom of Information Act request forms are available on the Village website Clerk's page at vofp.com or by calling the Clerk's Office. You may return forms by email or using the Village drop box. Garage sale registration can also be done by calling the Clerk's Office, about a week in advance of a sale with your information and a confirmed registration will be mailed to you. Due to a backlog in processing passports by the federal government, the Village is not currently able to offer Passport Services.

#### Water Bill Information

The Village strongly encourages residents and businesses to use our convenient online bill payment system to pay water bills. You can also pay your water bill via mail or put your payment in the drop box in the Village Hall parking lot (no cash).

Please note that each June the water rate rises to reflect the new rate charged by the City of Chicago to the Village. In addition, there is a small increase from the Village of Franklin Park which is used to fund critical infrastructure improvements. This new water rate will be applied to the July bills. Go to vofp.com to see more detailed rate information.

Funding from the Village's portion of the rate increase allows the Village to obtain low interest loans from the Illinois Environmental Protection Agency (IEPA) to support improving water and sewer systems in Franklin Park. Funds are currently being directed to a multi-year project in the Reuter Sub-division which is replacing sanitary sewer and water mains and increasing storm-water capacity to help prevent street flooding.

The cost of garbage removal has not changed and remains at \$22.96 per household for weekly garbage and recycling pick up. Senior citizens, 65 or older receive free garbage removal in Franklin Park.
