Protecting the Taxpayer

In November we announced three referendum questions that the Village Board of Trustees has placed on the March, 2016 ballot. One of those referenda asks residents if the Village of Franklin Park should become a unit of Home Rule government.

As you know, most of our neighboring communities are Home Rule. Home Rule status is allowed, by state law, to municipalities with a population of over 25,000. This binding referendum would give Franklin Park the same selfgoverning privileges.

We are very aware that many have concerns that if our Village becomes Home Rule, property taxes would increase. The Board of Trustees and I have conscientiously held the line on taxes for the last six years. Although the Village could have legally raised real estate taxes each of these years, we did not. We exercised restraint, as well as budget discipline to protect vou, the taxpayer.

The Board and I have a strong commitment to keeping costs low and responsibly using tax dollars. We made it a priority to find nonproperty tax revenue to improve our streets, sewers, and sidewalks through the 1% Non-Home Rule

sales tax. We also aggressively sought grants that allow us to enhance our Village and maintain the public safety without impacting the property tax.

Because of our sensitivity to property taxes, the Village Board unanimously passed a resolution pledging to abide the Property Tax Cap even if the Village becomes Home Rule.

The Illinois Property Tax Cap restricts real estate tax increases in non-home rule communities to no more than the rate of inflation or 5%, whichever is less. We pledge to you that we will abide by that Tax Cap.

Increasing Safety, Transit and Mobility

I want to offer our thanks to Senator Dick Durbin and our Congressman Mike Quigley for passing the FAST Act, Fixing America's Surface Transportation. This important legislation gives our region much needed resources for transit and highways. Of great importance to Franklin Park, and an aspect of the bill for which I lobbied, is increased safety regulations for freight trains


