## Lions Club Salutes Top Officer and Firefighter

The Franklin Park Lions-Manila Club recently selected Police Officer Joseph Vallejo and Firefighter Lt. Donald Johnston as their Police Officer and Firefighter of the Year.

Officer Vallejo has been a member of the Franklin Park Police force for over 23 years and has served as patrol officer, detective, truck enforcement officer and motorcycle instructor with the department. He was assigned for several years as a detective to the West Suburban Task Force (WESTAF), a multi-jurisdictional unit that investigates major crimes such as homicide and kidnapping. Throughout his career, Officer Vallejo was a leader who always demonstrated a willingness to assist other officers.

## Community Notes

### Keep our parkways

**unobstructed....** To insure the safe use of streets, alleys and driveways, Village Code prohibits placement of landscaping, building materials or other obstructions in the parkway that would hinder the use of the street or a driveway in front of your home. This will help prevent Village snowplows from colliding with snow-covered objects when they clear the streets. Failure to remove obstructions may require removal by the Village at a cost to the homeowner.

### Winter parking restrictions in effect....

There is **No Parking** on designated Snow Route streets after a 2" snow fall until clearing operations are complete. Secondary streets have a **No Parking** restriction after a 2" snow fall from 9 AM to 9 PM on the odd numbered side of the street and 9 PM to 9 AM on the even address side.

### Recycle electronics at two locations....

Leyden Township will accept residentially generated electronic items for recycling at 2501 N. Manheim Road and at a drop-off container at 9360 Franklin Ave. Call 847- 455-8616 for details.

### Vehicle sticker late fee to triple....

If you have not renewed your vehicle sticker for 2010-11, due last June, be advised that the \$30 annual renewal fee is now \$60 and will increase to \$90 on February 1. If you bought a new car, you must purchase a sticker that will be prorated to meet the June renewal cycle. Please phone 847-671-4800 for more information.
