AN ORDINANCE OF THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS APPROVING A GROUND LEASE AGREEMENT BY AND BETWEEN THE VILLAGE OF FRANKLIN PARK AND THE AMERICAN LEGION POST 974 FRANKLIN PARK

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the AVillage @) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the American Legion Post 974 Franklin Park (the "American Legion"), owns certain real estate located at 9757 Pacific Avenue, Franklin Park, Illinois 60131 and has agreed to lease a portion of said premises pursuant to a Ground Lease Agreement by and between the Village of Franklin Park and the American Legion (the "Lease"), a copy of which is attached hereto and made a part hereof as Exhibit A, in accordance with the terms and conditions therein specified; and

WHEREAS, the Village President and Board of Trustees of the Village of Franklin Park (the "Corporate Authorities") have determined that it is in the best interest of the health, safety and welfare of its residence to lease the parking lot adjacent to the American Legion in order to create additional parking and alleviate parking congestion and safety concerns in the immediate area surrounding the Metra station, the downtown business district and the Park District pool.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their

entirety.

- Section 2. That the Ground Lease Agreement by and between the Village of Franklin Park and the American Legion Post 974 Franklin Park, a copy of which is attached hereto and made a part hereof as Exhibit A, for a term commencing June 11, 2013 through June 10, 2016, is hereby approved substantially in the form presented to the Village Board, with such necessary changes as may be authorized by the Village President, the execution thereof to constitute the approval by the Village of any and all changes or revisions therein contained.
- **Section 3.** The Village President is hereby authorized and directed to execute and deliver the Lease and any and all other documents necessary to implement the provisions, terms and conditions thereof, as therein described.
- **Section 4**. The officials and officers of the Village are hereby authorized to undertake actions on the part of the Village as contained in the Lease to complete satisfaction of the provisions, terms or conditions stated therein.
- **Section 5**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- **Section 6**. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 7**. This Ordinance shall be in full force and effect immediately upon its passage and approval to ensure that the health, safety and welfare to the residents of the Village are duly protected and served.
