#### ORDINANCE NUMBER 1314-VC-

#### AN ORDINANCE AMENDING ARTICLE B OF CHAPTER EIGHT OF TITLE SEVEN OF THE VILLAGE CODE OF THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS (WATER AND SEWER SERVICE CHARGES)

WHEREAS, the Village of Franklin Park, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

**WHEREAS**, the City of Chicago (the "City") supplies the Village with water and the City establishes the rate it will charge the Village for such water each year; and

WHEREAS, the City notified the Village of a four-year rate increase and subsequently raised the rate by 25% for year 2012 and 15% for years 2013, 2014 and 2015; and

WHEREAS, in addition to the rate increases the Village must pay the City, the Village must also pay for the expense to operate, repair, maintain and upgrade the water and sewer systems servicing its residents; and

WHEREAS, because of the four-year rate increase by the City and need to repair the Village's aging and dilapidated infrastructure, the President and Board of Trustees of the Village of Franklin Park (the "Corporate Authorities") must ensure there is sufficient revenue to provide for the ongoing operation and repair of the Village's waterworks and sewerage systems.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Article B ("Service Charges") of Chapter 8 ("Water Systems") of Title 7 ("Public Works and Properties") of the Village Code of the Village of Franklin Park, Illinois, is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

#### 7-8B-2: RATES ESTABLISHED:

A. There are hereby established rates and charges for the use and services of the waterworks system of the village, as follows:

All users shall be charged at the rate of three dollars and nineteen cents (\$3.19) four dollars and ninety-five cents (\$4.95) per one hundred (100) cubic feet of water used each month between zero (0) cubic feet and nine hundred (900) cubic feet and shall be based upon the amount of water consumed as shown by the water meter, to be billed and paid monthly.

All users shall be charged at the rate of three dollars and ninety-nine cents (\$3.99) six dollars and eighteen cents (\$6.18) per one hundred (100) cubic feet of water used each month above nine hundred (900) cubic feet and shall be based upon the amount of water consumed as shown by the water meter, to be billed and paid monthly.

A minimum charge of six dollars and fifty cents (\$6.50) ten dollars and eight cents (\$10.08) per month shall be made.

B. There are hereby established rates and charges for the use and services of the sewerage system of the village, as follows:

All users shall be charged at the rate of 53,846 percent of the then current rate for water usage per one hundred (100) cubic feet of water used as shown by the water meter, to be billed and paid monthly.

A minimum charge of three dollars fifty cents (\$3.50) five dollars and forty-two cents (\$5.42) shall be made.

Sewer Service Only: Where sewer service is furnished, but not water, or where sewerage is discharged into a sewer, and the source of the water being supplied to the user is other than the village, then the rate charged shall be 53.846 percent of the then current village rate for water usage per one hundred (100) cubic feet of water used, as determined by statement of the water supplier or by estimate of the commissioner, whose determination of such estimate shall be binding upon the user.

**Section 3.** The amendments set forth in Section 2 of this Ordinance shall be used to calculate water and sewer usage for the next billing cycle, and thereafter, as shown by the water meter and to be billed and paid monthly.

**Section 4**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect immediately upon its passage and approval so that sufficient funds are available to the Village for the purchase of water and to provide such necessary funds to ensure that the waterworks and sewerage systems of the Village are operated, repaired and maintained at a level to protect the health, safety and welfare of the residents of the Village.

WHEREAS, the President and the Board of Trustees of the Village of Franklin Park (the "Corporate Authorities") have heretofore exercised the power conferred on them pursuant to Chapter 11-13-1, et seq., of the Illinois Municipal Code by adopting the Franklin Park Zoning Ordinance in 1974 (Ord. 7475 Z10), as amended from time to time;

WHEREAS, an amendment application, ZBA 13-14, has been submitted to the Village requesting certain amendments to Sections 9-1-3, 9-5B-3 and 9-8-4 of the Franklin Park Zoning Ordinance (the "*Proposed Amendments*"); and

WHEREAS, the Zoning Board of Appeals held a public hearing on August 14, 2013 as to whether the Proposed Amendments should be approved, at which time all persons present were afforded an opportunity to be heard; and

WHEREAS, a public notice in the form required by law was given of said August 14, 2013 public hearing date by publication not more than thirty (30) days nor less than fifteen (15) days prior to said public hearing date in the Franklin Park Herald-Journal, a newspaper of general circulation published in this Village; and

WHEREAS, the Zoning Board of Appeals has filed its findings of fact and recommendations that the Proposed Amendments be granted, and the Corporate Authorities have duly considered said findings of fact and recommendations; and

WHEREAS, the Corporate Authorities have determined, in the best interest of the health, safety and welfare of the residents of the Village, to further amend the text of the Franklin Park Zoning Ordinance (Ord. 7475 Z10), as amended.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

**Section 1.** The above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The President and the Board of Trustees finds and determines that the adoption of the Proposed Amendment is in the public interest, and is in furtherance of the progressive demands of orderly Village development.

**Section 3.** Section 9-1-3 of Chapter 1 of Title 9, entitled "Rules and Definitions," is hereby amended by inserting in alphabetical order the definition "Air Rifle Shop/Dispensary" and amending the definition "Sporting Goods Store," which such amendments shall read as follows:

AIR RIFLE SHOP/DISPENSARY: A retail operation in which air guns, air pistol, paint ball guns, spring guns, spring pistols, and B-B guns and any other implement that is not a fire arm which impels a breakable paint ball containing washable marking colors or, a pellet constructed of hard plastic, steel, lead or other hard materials with a force that reasonably is expected to cause bodily harm.

SPORTING GOODS STORE: A retail operation in which sporting equipment and complementary items are sold for consumer use, this use shall be prohibited from selling "air rifles" unless the applicant applies for and receives a conditional use for the sale of said items.

**Section 4.** Section 9-5B-3 of Chapter 5B of Title 9, entitled "Conditional Uses," is hereby amended by amending the following conditional use within Section 9-5B-3 to read as follows:

Body art shop (tattoo and piercing), except that such uses shall be limited to Grand Avenue from the eastern side of Mannheim Road east to the western side of Martens Street and no such uses shall be granted within five thousand two hundred eighty (5,280) feet of any preexisting body art shop.

**Section 5.** Section 9-5B-3 of Chapter 5B of Title 9, entitled "Conditional Uses," is hereby amended by adding the following conditional use to appear in alphabetical order within Section 9-5B-3 to read as follows:

Air rifle shop/dispensary, except that such uses shall be limited to Grand Avenue from the eastern side of Mannheim Road east to the western side of Marten Street and no such uses shall be granted within five thousand two hundred eighty (5,280) feet of any preexisting air rifle shop/dispensary, nor shall such uses be granted within one thousand (1,000) feet of any existing academic institution.

**Section 6.** Section 9-8-4 of Chapter 8 of Title 9, entitled "Schedule of Parking Requirements," is hereby amended by adding the following parking requirement in subsection H of Section 9-8-4 to appear alphabetically and read as follows:

Health Clubs/Gyms 1.0 space per employee plus 1.0 space per every 3 attendees based on rated design capacity

- **Section 7.** All sections of the Franklin Park Zoning Ordinance not addressed in this Ordinance or another amending ordinance shall remain in full force and effect.
- **Section 8.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- **Section 9.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 10.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

  - 1. The establishment, maintenance or operation of the Proposed Conditional Use, subject to the conditions set forth herein, will not be detrimental to, or endanger the public health, safety, morals, comfort, or general welfare;
  - 2. The Proposed Conditional Use, subject to the conditions set forth herein, will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminish and impair property values within the neighborhood;
  - 3. The Proposed Conditional Use, subject to the conditions set forth herein, will not impede the normal and orderly development of the surrounding property for uses permitted in the I-2 General Industry District;

- 4. The Proposed Conditional Use, subject to the conditions set forth herein, will not affect the exterior architectural appeal and functional plan of structures already constructed as to cause a substantial depreciation in property values within the neighborhood as the proposed plans will be an improvement upon the existing structure;
- 5. Adequate utilities, access roads, drainage and necessary facilities for the Proposed Conditional Use are already in place at the Property;
- 6. Ingress and egress for the Proposed Conditional Use, subject to the conditions set forth herein, shall minimally affect traffic congestion in the public streets;
- 7. The Proposed Conditional Use shall, in all other respects, conform to the applicable regulations of the I-2 General Industry District.

**Section 4.** A Conditional Use, subject to the conditions set forth below, is hereby granted and issued for the operation of a Health Club/Gym use in the I-2 General Industry District located at 9100 Belden Ave., Unit A, Franklin Park, Illinois, and legally described as follows:

### SEE EXHIBIT A ATTACHED HERETO.

These conditional use permits are subject to the following conditions:

- 1. That an affidavit be submitted by Haribhai Patel acknowledging and covenanting that six (6) on-site parking spaces shall be reserved for the operations related to this Conditional Use;
- 2. That all customer and employee parking shall occur on-site as off-site parking shall be strictly prohibited;
- 3. That the Conditional Use shall be limited to the area designated as Unit A in the Plat of Survey submitted as part of the record at the August 14, 2013 public hearing;
- 4. That the Conditional Use at the Property complies with all other codes and ordinances of the Village of Franklin Park;
- 5. That this Conditional Use shall be limited to Angelo Sisco and shall not be transferable except upon reapplication, hearing and approval in the manner provided in the Franklin Park Zoning Ordinance; and
- 6. This Ordinance shall be signed by the Applicants to signify their acknowledgement of the terms hereof.

**Section 5.** The Applicants hereunder shall at all times comply with the terms and conditions of the conditional use and in the event of non-compliance, said permit shall be subject to revocation by appropriate legal proceedings.

**Section 6.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 7.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 8.** This Ordinance shall be in full force and effect following its passage, approval and publication in pamphlet form as provided by law.
