 - A. FINANCE AND SPECIAL EVENTS COMMITTEE (Mr. Johnson, Chair)
 - 1. MR. JOHNSON STATED ON CONSENT AGENDA THEY WILL BE ABATING TAX DEBT SERVICE ON THREE ITEMS. MR. JOHNSON STATED RON HELLER EXPLAIN MORE ABOUT THIS

- B. WATER AND SEWER/FLEET MAINTENANCE COMMITTEE (Mr. Ruhl, Chair)
 - 1. MR. RUHL REPORTED THERE HAVE BEEN TEN WATER MAIN BREAKS SINCE THE LAST MEETING.
 - 2. MR. RUHL STATED THE RECENTLY PURCHASED TRACTOR HELPED OUT A LOT WITH CERTAIN AREAS OF SNOW REMOVAL BY CUTTING THE SNOW REMOVAL TIME IN HALF
 - 3. MR. RUHL STATED EVEN THOUGH THERE IS A WARM UP, THE GROUND IS FROZEN FOUR FEET DOWN. MR. RUHL WARNED PEOPLE TO STILL USE PRECAUTION CONCERNING THEIR PIPES BY CONTINUING TO LET THE WATER TRICKLE OUT. THIS WILL PREVENT THE PIPES FROM BURSTING

 - 1. MR. PETERSEN STATED THE POLICE AND FIRE COMMISSION IS WAITING ON THE RESULTS OF A PHYSICAL FOR THE THIRD FIREFIGHTER TO BE HIRED
 - 2. MR. PETERSEN REPORTED THE NEW POLICE OFFICER IS IN HIS FINAL MONTH OF TRAINING AND DOING WELL
 - 3. MR. PETERSEN ANNOUNCED THE 911 COMMISSION HAS GONE OUT FOR BIDS FOR THE BACK-UP 911 CENTER
- D. STREETS, ALLEYS AND FLEET MAINTENANCE COMMITTEE (Mr. Ybarra, Chair)
 - 1. MR. YBARRA STATED SINCE THE LAST MEETING, THE STREET DEPARTMENT HAS BEEN BUSY WITH TWO SNOW PLOWING EVENTS. THERE HAVE BEEN 260 TONS OF ROAD SALT USED AND 55 GALLONS OF LIQUID CALCIUM CHLORIDE. THE DEPARTMENT HAS ALSO USED 31 BAGS OF SPECIAL BLEND SIDEWALK SALT FOR VILLAGE BUILDINGS AND 72 SCHOOL CROSSWALKS.
 - 2. MR. YBARRA REPORTED 34 TONS OF COLD PATCH HAS BEEN APPLIED TO THE ROADWAYS TO REPAIR POTHOLES

 - 1. MS. SPECIAL STATED ERIC RICHARD WILL SPEAK ABOUT THE THREE ZONING ORDINANCES ON THE CONSENT AGENDA
- F. HEALTH, HUMAN RESOURCES, SUSTAINABLE PRACTICES AND SENIOR SERVICES COMMITTEE (Ms. McLean, Chair)
 - 1. MS. MCLEAN REPORTED ON THE "LET'S MOVE" MEETING.
 DISTRICT 84 IS PUTTING TOGETHER A COMMUNITY FITNESS NIGHT
 TO BE HELD AT HESTER JUNIOR HIGH ON MARCH 18
 - 2. MS. MCLEAN ANNOUNCED THERE WILL BE NO BLOOD DRIVE IN MARCH. THE NEXT BLOOD DRIVE WILL BE HELD IN JUNE

VII. STAFF REPORTS AND COMMENTS; DISCUSSION ON AGENDA ITEMS

- 1. Ron Heller spoke about agenda items 7-10 regarding abating the tax levied for the year 2013 to pay debt service. Mr. Heller stated items 7-9 are abated every year. Item #10 is the first step in abating the debt service that underlies the bonds for the increased water/sewer rates
- 2. Chief Iovinelli spoke about a fire that occurred this past Saturday at a vacant tire store on Mannheim and he reported the fire took longer to extinguish because of the lack of water supply. Chief Iovinelli complimented the Village's water supply. Chief Iovinelli spoke about the third firefighter to be hired. Chief Iovinelli announced the St. Baldrick's fundraiser will be held on Friday, March 7
- 3. Chief Witz spoke about consent agenda item #5 regarding public morals nuisance violations. Chief Witz spoke about consent agenda #6 regarding an agreement with Schiller Park for the use of the Franklin Park Police Department firing range facilities. Chief Witz announced police negotiations begin tomorrow with the Fraternal Order of Police. Chief Witz spoke about meeting with Sloan Valve and the Leyden Credit Union to discuss workplace violence. Chief Witz announced this Saturday is "Coffee with the Chief" and over 30 people have signed up to attend. Chief Witz spoke about working on another auction for March. Chief Witz reported minors were arrested in the U.N. Club bar. Chief Witz announced he received word that retired officer Ed Kemph has a serious illness
- 4. Vernel Miller announced E-pay is up and running on the Village website. Mr. Miller spoke about being in the final negotiations with AT&T and Comcast for a 3-year contract for communications
- 5. Eric Richard spoke about agenda item #11 regarding a conditional use to allow a restaurant use in the I-1 restricted industrial district at 3853 Carnation Street, Unit B. The restaurant (Sorento's) is relocating to Franklin Park. Mr. Richard spoke about agenda item #12 regarding allowing a chemical processing and manufacturing use in the I-2 general industry district at 11142 Addison Street. The company is called Plating International and they are relocating to Franklin Park from Melrose Park. Mr. Richard spoke about agenda item #13 regarding a conditional use to allow an automobile repair facility at 9001 Exchange. Lastly, Mr. Richard spoke about agenda item #4 regarding authorizing and approving a community development block grant program application for program year 2014. These funds are being applied for so they can be used for a street improvement project
- 6. Joe Lauro spoke about how much the recent storm events have cost the Village. Mr. Lauro reported Fleet Maintenance has been working hard to keep equipment up and running. The approximate cost so far for staff time, fuel, salt, rental, etc. is \$720,000
