Mr. Heller spoke about being in the process of developing the tax levy ordinance. Mr. Heller spoke about the reason for item #3 on the Consent Agenda
- 2. John Schneider spoke about three new businesses in the Village, Big Lots, Red Rose Gifts & Flowers, and Hop Scotch, opening up. Mr. Schneider spoke about his meeting with the owner of Portillo's Deli who will be opening up a grocery store. Mr. Schneider announced Romano's at 10007 Grand Avenue will be opening up a dry goods store. Mr. Schneider met with a group who bought Encore Restaurant. Mr. Schneider spoke about his November 7 meeting with the Cook County Bureau of Economic Development and Department of Environment. President Pedersen attended the meeting with him. They were asked to participate in the application for environmental assessments of sites in Franklin Park. Mr. Schneider spoke about meeting with Kurt Kugelberg to discuss ideas for Franklin Park. Mr. Schneider and President Pedersen spoke about ComEd's industrial vacancy rate report
- 3. Steve Scheffel spoke about Reeves Court being substantially complete with a few punch list items left to go. Mr. Scheffel reported the Elm Street water main project has gone out for bid. The bid opening is set for December 6. Mr. Scheffel spoke about the favorable response he received from the Illinois Department of Natural Resources on the Village's audit for compliance with the flood plain ordinance
