1. Mr. Eder stated the Board should have received in their packets a notice for the public meeting regarding the Elgin/O'Hare project. The hearing will be held on March 11, from 4:00 p.m. to 8:00 p.m., at the Elk Grove Village Belvedere Banquet

Hall. They will be discussing how to move traffic through the western side of O'Hare that connects to Elgin/O'Hare. They would also like to build a new bridge over the tracks by Irving Park Road and Taft Avenue

1. Ms. Szymanski reminded everyone that tomorrow is the Primary Election and all polling places will be open from 6:00 a.m. to 7:00 p.m. and voter's registration is open until March 10, for the April 7 Consolidated Election

1. Mr. Gregory Heath, 2215 Mannheim Road - He would like to see Franklin Avenue widened west of Mannheim Road

XI. COMMENTS AND APPOINTMENTS FROM THE PRESIDENT

- 1. Mr. Pritchett stated speaking of Franklin Avenue, first of all the history of the railroads, the history of our country, most railroad right-of-ways were granted to the railroad for the construction of those railroads and tremendous benefits were given and of course it was a monumental undertaking, but things like property taxes and the right-of-ways were granted to them in perpetuity so most railroad tracks run relatively tax free. We received notice last week that we are going to be the recipients of A \$950,000 grant, an earmark that we've been working on for about a year that is designated for Franklin Avenue so that is \$1 million of a proposed \$9 million construction project. Mr. Pritchett stated we are about 10% of the way there. Mr. Pritchett has not seen the bill yet as to see what it's tied to but Mr. Pritchett will be in Washington to seek the other \$8 million
- 2. Mr. Pritchett stated the Village had another snow/rain scare again a couple days ago. Mr. Pritchett and Mr. Thomas cruised around to make sure everything was under control. Mr. Pritchett said his heart goes out to the people of Lee Street and Belmont Avenue because it doesn't take much for them to get nervous now. When Mr. Pritchett visited the Panoramic Avenue and Ernst Street area, there was a lot of water but the manhole was taking in the water. The Lee Street and Belmont Avenue area residents still insisted on sandbags. Mr. Pritchett stated he had Rich Pena investigating the idea of possibly having a P.O.D. container put in a central location perhaps behind K Mart where they could have the sandbags in the unit ready to go. This would be easier to load
- 3. Mr. Pritchett stated he met with The Cook County Housing Authority on February 19. The Board voted unanimously for the senior only status. The Cook County Housing Authority has a completed draft and sent it to Washington and it is a matter for Washington to review. Mr. Pritchett will be in Washington soon to point out the highs and the lows and see if there is anything else they could require to get our Senior Towers back to senior only status
- 4. Mr. Pritchett stated on February 22 the scouts put on the Blue/Gold Dinner at the United Methodist Church. The place was packed and it was a great event

- 5. Mr. Pritchett stated on February 24 students met for the preparation of "Student Government Day" which will be held on March 16
- 6. Mr. Pritchett stated there was a GARRA meeting on Friday, February 27
- 7. Mr. Pritchett announced there will be an electronics collection April 24 and April 25 at Triton College. Any computer equipment, computers, telephones, answering machines, cell phones, fax machines, television, VCR's, stereo equipment, software, discs and CD's can be dropped off
- 8. Mr. Pritchett stated he will soon be in Washington, D.C. to check on the \$950,000 grant plus continuing to work on the Silver Creek basin funding so we can finish the final pieces of that project and the pedestrian bridge on Franklin Avenue
- 9. Mr. Pritchett stated Sonic Restaurant has signed papers to be the third build out on Grand Avenue and Mannheim Road and they are excited about this
- 10. Mr. Pritchett stated Elgin, Joliet and Eastern (EJ&E) project did go through and this will mean less trains for Franklin Park
- 11. Mr. Pritchett stated he received a card from David Nemec thanking him for taking time out of his schedule to speak to the 5th grade classes on the history of Franklin Park
