Mr. Pritchett stated he received a letter from Bob Johnson, Assistant Superintendent East Leyden High School, thanking the Mayor for his commitment to the police liaison program and Officer Melissa Jones who does an exemplary job as a critical link between the school and the community. Mr. Johnson and the school look forward to having Officer Jones for the 2009/2010 school year. In order to complete his budget for next year, Mr. Johnson would like to know before May the per diem rate of the district we charge as well as any other changes the Village foresees.
- 2. Mr. Pritchett stated he received a call from the newly elected Congressman Quigley's office last Thursday. They are transferring all of the Mayor's requests on the earmarks from Rahm Emanuel's and Dick Durbin's office to Congressman Quigley's office. Mr. Pritchett stated they are very interested in the Silver Creek Basin Project and in helping the Village procure the funding and begin construction for the pedestrian bridge on Franklin Avenue
- 3. Mr. Pritchett stated he received a letter April 6, that was in response to the Cook County Housing Authority's proposed designation housing plan that was received in HUD's office on February 24. The plan designates 569 units for "elderly only." The plan will be in effect for five years from the date of the letter and prior to the expiration of the plan, the HACC may apply to extend the plan for an additional two years
