- A. FINANCE AND SPECIAL EVENTS (Mr. Johnson, Chair)
 - 1. MR. JOHNSON STATED THE VILLAGE IS WORKING ON THE FINANCES EVERYDAY IN ORDER TO GET CONTROL OF THE SITUATION AND SOME OF THOSE ISSUES WILL BE DISCUSSED IN EXECUTIVE SESSION
 - 2. MR. JOHNSON STATED ONE OF THE TOPICS IS THE GARBAGE FUND, WHICH MIGHT BE TRANSFERRED TO THE RESIDENTS AND THE BOARD WILL NEED TO MAKE A DECISION
- B. WATER AND SEWER/FLEET MAINTENANCE (Ms. Rodriguez, Chair)
 - 1. MS. RODRIGUEZ STATED SHE HAD NOTHING TO REPORT AT THIS TIME
- C. POLICE AND FIRE (Mr. Johnson, Chair)
 - 1. MR. JOHNSON STATED THE POLICE AND FIRE COMMISSION MEETING WAS EARLIER THAT NIGHT AND THEY WILL BE GOING OUT FOR TESTING FOR THE POLICE AND FIRE CANDIDATES BECAUSE THE LIST IS EXPIRING

- D. STREET AND ALLEY/FLEET MAINTENANCE (Mr. Brimie, Chair)
 - 1. MR. BRIMIE ANNOUNCED FRANKLIN AVENUE IS ALMOST DONE AND THE ASPHALT HAS BEEN FILLED IN
 - 2. PRESIDENT PEDERSEN STATED MR. TALBOTT REPORTED THAT WEATHER PERMITTING, THEY WILL BE POURING CEMENT FOR THE SIDEWALK NEAR PHASE II ON FRANKLIN AVENUE
