• Chief. lovinelli asked how much money is owed. Mr. Thomson stated money is owed from 2009 in the amount of \$218,271.11. Chief. lovinelli asked how much were they direct depositing. Mr. Thomson stated anywhere from \$2000.00 up to \$2,400.00. Mr. Thomson explained once every year in the month of June, it has been \$21,000.00, \$32,000.00, \$35,000.00. Mr. Kemph explained in 2009, T-Mobile acquired the account number for direct deposit and they began direct depositing the rental fee for T-Mobile's equipment on the water towers to the 911 Board account instead of the Village. Mr. lovinelli suggested approaching the Village with some kind of payment plan. Mr. Thomson stated he recently talked with Village Attorney Joe Montana about this matter and Mr. Montana suggested having it paid back over a 10-year period. There was discussion on how much to pay back per month. Mr. lovinelli suggested a monthly transfer of \$10,000.00 from the 911 Board account to the Village's general fund account. Mr. Thomson suggested having the Village attorney draw up an agreement with the Village.

Motion made by Mr. Iovinelli, seconded by Mr. Thomson to have the 911 Board enter into an installment payment program with the Village of Franklin Park in the amount of \$10,000 per month to pay off the T-Mobile balance.
