## NEW BUSINESS

- National Emergency Alert Test scheduled for Wednesday, November 9 at 2 pm in the afternoon; should only last about 30 seconds. This is a nationwide test.
- IMET computer at fire station #2 is still not working. Dionne said she would contact the company that handles those to see what can be done. Discussion as to whether or not we can get another IMET computer for the public works department
