CALL TO ORDER: President Witnik called the meeting to order at 5:04 pm.

APPLICATION FOR RETIREMENT AND DISABILITY BENEFITS: *Chief Michael Witz Retirement Benefit Calculation:* The Board reviewed the retirement benefit calculation for Chief Michael Witz, as calculated by L&A. Effective date of pension is 01/19/2016; 32 years of creditable service; applicable salary of \$123,936.27; percentage of salary 75%; for an original monthly benefit in the amount of \$7,746.02. A motion was made by Trustee Winje and seconded by Trustee Viken to approve the retirement benefit calculation of Chief Michael Witz as presented. Motion carried by roll call vote.

Participant Board Report: L&A distributed the Participant Board Report for the Board to review.

OLD BUSINESS: *Officer Norman Carli Jr.:* The Board discussed the pending line of duty disability application of Officer Carli and noted that Officer Carli's three (3) independent medical examinations (IME's) are currently scheduled/in progress. This matter is tabled to the next regular meeting.

Disability Application of Officer Christopher Sardo: The Board discussed this matter and noted that two (2) IME's have been conducted. Officer Sardo's attorney is objecting to the third physician and will be filing a motion to obtain a different physician to conduct the third IME. This matter is tabled to the next regular meeting.

NEW BUSINESS: Trustee Term Expiration / Reappointments / Election Process: The Board noted that Trustee Witnik's Active and Trustee Viken's Retired positions on the Pension Board are expiring April 30, 2016. Trustee Jensen will conduct the Active position election and the Board directed L&A to conduct the Retired position election on behalf of the Pension Board.

The Board noted that Trustee Winje's Appointed position is ongoing at this time.

Statements of Economic Interest: All trustees were reminded to complete the filing of their Statements of Economic Interest to the County by May 1st.

INVESTMENT REPORT: *Quarterly Investment Report:* Mr. Antioho distributed the Quarterly Investment Report for the 4th quarter 2015 for the Board to review. The ending market value of the Fund as of the end of the 4th Quarter 2015 is \$22,447,585.92. The total Fund performance for the 4th quarter 2015 was 2.62% and year-to-date was 0.65%. The portfolio allocation as of 12/31/2015 is: Domestic Equities 44.6%; International Equities 6.3%; Fixed Income and Cash 46.1%; and Real Estate 3.0%. A motion was made by Trustee Viken and seconded by Trustee Waychoff to accept the Quarterly Investment Report as presented. Motion carried by unanimous voice vote.

Potential purchase and/or sale of securities, re-balancing of asset allocations and hiring/termination of investment managers: None at this time.

CLOSED SESSION: There was no closed session.

ADJOURNMENT: A motion was made by Trustee Viken and seconded by Trustee Jensen to adjourn the meeting at 6:08 pm. Motion carried unanimously by voice vote.
