#### III. COMMITTEE OF THE WHOLE

### GREEN TECHNOLOGY AND EDUCATION

1. Plug-in Vehicle Solutions

Bruce Lanzerotti and Michael Piscitelli from Plug-in Vehicle Solutions conducted a presentation on an electric car charging program to the trustees. They announced that they represent six manufacturers of charging stations and they also discussed how sponsorship may be obtained to pay for the stations.

#### V. PRESIDENT'S COMMENTS

President Pedersen commented on a previous comment at another meeting that he had made referencing the term Drunkin Sailor and a resident took offense to the remark as they thought the term was a derogative term about people serving in the Navy. President Pedersen stated his comments were in no way referencing anyone in military services and that it is the title of a song used widely. He displayed a song program used by the Boy Scouts of America Chicago Area Council titled "Owasippe Legends, Ballads & Vignettes" in which the song was included in their list of sea songs.

President Pedersen stated he and the board are developing a budget now as the audits are complete and they are applying the best and most professional and accepted accounting practices to this process that will be a guide to meeting priorities. He stated it was imperative to demonstrate budget discipline and take a conservative approach to spending and all accounts are open for review.

President Pedersen announced eight companies have eight moved into or expanded their business in Franklin Park during March. Those new include Romano Restaurant, Master Food Brokers, Inc., Mega Driving School, Royal Service Realty, Healthwise Healthcare, Everst Home Healthcare and companies expanding are Cortina Tool and Reebie Storage.
