President Pedersen discussed the reduction in Village personnel and the garbage fee amount that has been added to the water bill

Village finances, 1 person commented on grants, 1 person commented on his water bill, 1 person commented on hexagrams, 1 person commented on Bell's guns, 2 people commented on the budget and 1 person commented on cutting costs by not purchasing plants and flowers to decorate the Village
