1. WHAT IS YOUR WATER WORTH

President Pedersen introduced and gave some background information on Mr. Josh Ellis from the Metropolitan Planning Council. Mr. Ellis gave a Powerpoint presentation and reported on the Northeastern Illinois water supply. Mr. Ellis spoke about the Northeastern Illinois Regional Water Supply Planning Group. This group is made up of eleven counties in Northeastern Illinois and for the last three years they have been studying supply and demand trends in the region. Mr. Ellis reported on some of this group's findings and on what happens with the water every time it rains. Mr. Ellis also reported on the TARP system
