- 1. The regularly scheduled meeting of the Zoning Board of Appeals was called to order at 7:00 p.m.

- 5. New Business: Staff Update & Presentation on Grand Avenue Corridor Study from CMAP

Mr. Repa began a presentation to the members of the status of the Grand Avenue Corridor Plan. He discussed the planning process timeline from when it began in the summer of 2023 and expects the final draft to be released approximately February of 2025. He explained that there was robust community outreach which included cavassing, attending various events throughout the years as well as three steering committee meetings.

Mr. Repa described the plan structure which included seven goals, nineteen recommendations and ninety-six strategies. All would be outlined within the plan.

Some goals that were discussed this evening were presented as follows:

- Goal 1: Create a unified corridor.
- Goal 2: Ensure Grand Avenue is resilient to changing market conditions.
- Goal 3: Improved transportation.
- Goal 4: Safety.
- Goal 5: Diversify housing along Grand Avenue.
- Goal 6: Leverage to promote climate resilience in Franklin Park.
- Goal 7: Improve quality of & access to natural assets.

Mr. Repa concluded this presentation at this time.

Mr. Repa discussed various other ongoing projects within the Village. Some projects he expounded upon were the Village Plaza on the corner of 25th and Franklin Avenue. Some examples were signs for the downtown district, public parking signs, B-12 Tower, village square and a visitor directory sign.
